**ELIGIBILITY REQUIREMENTS TO PARTICIPATE IN THE
2011 KS STATE USBC WBA CHAMPIONSHIP TOURNAMENT**

All entrants must be members in a local WBA/merged association, Kansas State USBC WBA and USBC or have a current USBC Associate membership card. Bowlers who are not members of a local WBA/merged association or Kansas State USBC WBA, must purchase a current USBC Associate Membership card (\$11.00).

Parental Consent:

Unmarried students under the age of 18 must furnish a written consent signed by their parent or guardian.

Average Requirements:

Entrants shall use their highest USBC sanctioned Kansas league average, as a regular or substitute.

Follow this order in determining average:

1. — as of the end of the 2009-2010 winter season, providing they have bowled 21 games or more.
2. — as of the end of the 2010 summer season, providing they have bowled 21 games or more.
3. — if neither of the above, highest current league average of 21 or more games as of January 1, 2011. (If entry submitted prior to January 1, 2011, please send verified average as soon as available.)
4. — if none of the above, highest current league average for 12 games or more as of the date of participation in the KS State USBC WBA Championship Tournament.

All reference to averages shall include only those averages established in leagues sanctioned through local associations within the defined sanctioning area of the Kansas State USBC WBA. ALL OTHERS BOWL SCRATCH.

Handicap shall be 100% of 225.

THE LOCAL ASSOCIATION MANAGER IS RESPONSIBLE FOR VERIFYING AVERAGE & MEMBERSHIP OF THE INDIVIDUAL ENTRANT. All winners' averages subject to further verification by KS State USBC WBA tournament management.

TEAM CAPTAIN must be a participating member of the team.

This year we have a four-woman and five-woman format with dual participation in the team event only, first team event to count for all events. The same four women plus one more can make up a five-woman team.

Entrants shall participate only once in each event - 4-woman team, 5-woman team, doubles and singles. Scores bowled by an ineligible player will be disqualified. All events will be based on first team event (either 4 or 5 member).

KS STATE USBC WBA WILL NOT ACCEPT AN UNSIGNED ENTRY OR AN ENTRY ACCOMPANIED BY PARTIAL FEES.

Entry fees for team, doubles, and singles must be paid **in full** at the time the entry is submitted. Fees for one person in doubles and singles events does **not** constitute full fees. Fees for two people must be paid before KS State USBC WBA will schedule. **A \$20 FEE WILL BE ASSESSED FOR ALL RETURNED CHECKS.**

All Events fees must be paid when entries are submitted and **cannot be paid after January 10, 2011.**

Prize distribution: Team, Doubles, Singles: 1 prize per 5 entries. All events: 1 prize per 10 entries. All prize money collected in an event shall be returned to the participants in that event.

When KS State USBC WBA Association Manager notifies entrant of dates/times assigned and a refusal has not been received within 15 days of this notice, the entry fee shall not be refunded.

ENTRANTS ARE NOT PERMITTED TO SMOKE WHILE PARTICIPATING IN ANY TOURNAMENT EVENT.

Any entrant guilty of gross misconduct or unnecessary delay of game, may be disqualified from the tournament at the discretion of the tournament manager.

To the Association Manager of the KS State USBC Women's Bowling Association: We, by our captain and agent, hereby make application to participate in the KS State USBC WBA 2011 Championship Tournament events listed and tender the entry fees required therefore. We warrant that we are USBC and KS State USBC WBA members. We agree to abide by all tournament and playing rules and regulations prescribed by KS State USBC WBA, including all provisions set forth on this form. We specifically agree for ourselves and any replacements chosen by or for us that if we are not eligible for participation in the KS State USBC WBA Championship Tournament, then our prize, bowling and expense fees shall be forfeited and all sums tendered by us as prize, bowling and expense fees may be retained by the KS State USBC WBA as liquidated damages. The entrants whose names appear hereon or their authorized replacements hereby agree that the KS State USBC WBA, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling in any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting therefrom, fires, strikes, lockouts, labor difficulties or other causes beyond the control of the KS State USBC WBA.
